Grants will be made for: research projects which advance assessment in rural and small jurisdictions; publication of technical articles on rural issues; and for support of the activities of the IAAO's Rural and Small Jurisdictions Issues Section.

Grants for research on rural issues are based on the importance of the issue to rural appraisers. Projects must be approved in advance, and payment of the award is contingent upon receipt of a report of the research results.

Published articles on rural issues are reviewed by the Trust Committee. Decisions are based on the appropriateness of the article and the perceived importance of the topic, as well as the availability of funds. Applicants for publication awards need not answer the following questions but should submit a letter of explanation along with a copy of their published article.
